The net revenue of the Company has been growing steadily from 2015 to 2017. Specifically, revenue will increase from VND 21,462,513 in 2015 to VND 23,949,605 in 2016 and VND 25,416,279 in 2017. Of which, net revenue from water supply activities (the main activity of the company) accounts for a large proportion (about 75% on average) in total net revenue. In addition, installation revenue and average revenue contributed a large proportion of total revenue (about 25%). Growth Net revenue of the company is partly due to the recovery of the state-owned economy and the company's good business plan, the development and expansion of new customers also facilitates the growth. Annual sales revenue of the company.

In addition to its core business of providing clean water, the company also produces and supplies bottled water (20-liters bottled water) to meet the needs of local people, organizations and agencies. to provide the services of construction and installation of water supply works in the area: installation of water supply pipes, gauges, reservoirs and related works.

The company's net revenue growth was partly due to the company's good business plan, and the development and expansion of new customers also facilitated the company's annual revenue growth.

- b) Materials
- Material source:

With the main activities of supplying public services in Kon Tum province, the Company's activities include two main areas: producing and supplying clean water, producing bottled water; Construction and installation of water supply projects.

With the main activities of supplying public utility services, the company mainly performs its production and business tasks in Kon Tum province. Its activities include 2 main areas: Production and supply of clean water, production of bottled water; Construction and installation of water supply projects.

For clean water production and supply:

Business activities of the company mainly use natural water (underground water and surface water). In addition, the company also uses auxiliary materials for water

Stability of raw materials:

In general, because the materials used for business activities of the Company is quite simple and popular, the company has many advantages in choosing suppliers with reasonable price and stable supply, contributing to improving the business efficiency of the Company. Therefore, it can be said that Kon Tum Water Supply Co., Ltd has a stable supply of raw materials and fuel, which helps the Company to be proactive in production, ensuring the development of business activities of the company.

Influence of raw material price on revenue and profit:

The price of raw materials increases dramatically and impacts on revenue and profit. As aware of this problem, Kon Tum Water Supply Co., Ltd. has applied many saving measures to minimize the fluctuation of raw material prices. The cost of goods sold in the cost structure is quite large so the fluctuation of raw material prices will directly affect the revenue and profit of the company. In recent years, due to the general economic impact of the global economic crisis, the prices of raw materials fluctuate continuously in accordance with electricity prices; The rise in prices of goods and services also has a significant impact on the Company's business performance

Looking at the company's operating expenses, the Company's total expenses have changed in value but the proportion of expenses / net revenue has not changed much, accounting for 93.5% to 95% net revenue. In particular, cost of goods sold accounted for a large proportion, on average over 80% of net sales, management costs accounted for about 14%. The high ratio of cost to net sales has a great impact on the company's production and business performance

e) Technology level

Recognizing the importance of services provided by the company, the company

actively adopts advanced technology equipment in the technical management of water supply system. In order to serve its operation continuously and without interruption, the Company has invested in advanced machinery and equipment, suitable for the needs of operation, this has contributed a large increase productivity, improved the performance of the company.

Not only focus on the supply, so that the production operation is optimized, in the past years, the company has always paid special attention to the prevention of loss, loss of water. By installing control systems for the operation of water supply networks such as: Installation of intelligent valves in each area to regulate the pressure, installation of electronic meters, ... has helped the management of the pipeline system, leak detection, avoidance of water losses become more effective.

f) Research and development of new products

With business characteristics of the business activity is mainly serve. Therefore, research and development of new products is not a target that the company attaches importance to. At present, the Company mainly focuses on researching measures to improve the quality of water supply services to customers, meeting the needs of both individual customers and institutional customers.

g) Quality management system

Determining the quality of products and services is a vital issue so the Board of Directors and all staffs of the company always pay attention and seriously. The work flow of each pump station is managed and monitored through the Operation Log and Performance Report. Daily water quality control is carried out by the laboratory under the Department of Materials Engineering to control water quality. In addition, the water quality inspection of the Company at the Water Supply Plant is under the control and supervision of the Provincial Centers for Disease Control under the Kon Tum Department of Health.

It is expected that after completion of equitization, the Company will develop and apply management procedures, regulations and quality standards in accordance with relevant laws.

The network of water pipelines of the company is always checked and handled in time. Every month, employees and subordinates regularly inspect, replace, repair and maintenance of pipelines and water supply equipment.

h) Marketing system

The prestige of the company is built mainly thanks to the quality of services provided by the company. The company has not used many marketing tools to promote the image to the public. Currently, the company has no own website, not promote the

media in the neighborhood but mainly lack of products and activities through the collection of water, some mass media bear Small local tissue such as: radio stations, Kon Tum provincial television and local newspapers, and implement programs and policies under the direction of the provincial People's Committee.

The company determines the importance of marketing in the current market economy. Therefore, it is expected that after the equitization, the Company will make proper investment in this activity, giving appropriate marketing strategies for each period, contributing to the success of the Company in the organization. Implementation of business strategy.

3. Factors affecting the production and business activities of the Company

a) Advantages:

Kon Tum Water Supply Co., Ltd always receives the attention and guidance of all levels and branches, thus creating favorable conditions for the company to develop and expand its production and business activities.

Clean water is essential for consumers. The quality of life is increasing, the society is growing and demand for clean water is increasing. The pace of development of Vietnam's economy is in the period of prosperity, the speed of urbanization of the country is getting faster and urban areas are growing in large numbers. In order to ensure the quality of life of the people, it is necessary to develop and expand the service sector to serve clean water business in order to develop in line with the urbanization process of the country. However, the infrastructure system is inadequate and inconsistent, especially water supply, drainage and water treatment systems, so the investment needs to build water supply and drainage projects in the future, hybrid is very large.

With the business model of sustainable development based on increasing value added for local people and the responsibility of the employees in the company, the company has always been received the steering and support from all levels of government and long-term commitment, building and development of all staffs of the company in the past years.

Qualified and skilled staffs with adequate means of transport to meet the requirements of work, ensuring the volume and quality of services provided as well as the capacity to participate in bidding Project on the management, exploitation and operation of water supply works in Kon Tum province.

Besides, the company always performs well the coordination with the local: Department of Finance, Department of Planning and Investment; The Department of Construction ... enlisted for the guidance of the higher level to timely take measures to organize implementation close to the actual situation in the company.

b) Difficult

On the impact of macro factors: The production and business conditions of the company are facing many difficulties and challenges due to the impact of the economic recession, the cost of raw materials, chemicals, electricity, etc., which is constantly increasing, leading to production costs. clean water; Especially due to climate change, the urbanization and craft villages develop spontaneously, seriously affecting the water supply for production and living for the people; Investment in water supply network expansion projects is difficult due to limited funding.

About facilities: Infrastructure of water supply is lacking and old, many degraded works are not upgraded and renovated every year. The investment in new construction, renovation of old works, investment in procurement of advanced equipment still faces many difficulties due to the company's budget is limited.

In addition, the business activities in the water business is both business and social security to ensure stable life in the province. Therefore, the sale price of clean water has not been adjusted in time, not fully reflecting the actual costs of production and circulation, while the price of raw materials is rising, the water price bracket is regulated by the State. The company is not allowed to adjust according to the actual situation, which directly affects the production and business efficiency of the Company. Besides, the company has difficulty with narrow market segment, business activities are not diversified so the expansion of the market is not easy.

IX. THE POSITION OF THE COMPANY WITH OTHER ENTERPRISES IN THE INDUSTRY

1. Company's position in the industry

Started in 1999, the company has over 19 years of experience in providing services of management, exploitation, production and business of clean water for living and production in the province of Kon Tum. Not only that, the company also provides bottled water products produced under strict quality control, ensuring to provide consumers with clean drinking water products in accordance with the standards of quality as prescribed.

However, due to the characteristics of the water companies are distributed in each province, with the main purpose is to provide clean water to meet the needs of production and living of people in the province. there. Therefore, the size of the company will grow according to population size and economic development of the province. Kon Tum is a

province located in the Central Highlands, the underdeveloped economy of the country. Compared with other water supply companies in other provinces, the company has average capital and technology level suitable with the economic development level and population size of Kon Tum province.

2. Development prospects of the industry

Clean water is a service of goods, products produced by the people and economic sectors immediately. Due to the high monopoly and characteristics of the product, it has created many advantages for the company to conduct production activities to improve business efficiency.

The growth rate of the water sector is closely linked to the level of population growth and the speed of urbanization and industrialization of the country. In 2017, our population ranked 14th in the world, increased 1.07% over the previous year. Forecasts for 2018, a natural population increase forecast positive, is expected to average an increase of 2,600 people per day. Along with that, the economic growth rate recorded the change flourishes, GDP increased 6.81% compared to 2016. In the first 6 months of 2018, GDP is estimated to increase by 7.08% over the same period last year. With the economy growing, the demand for clean water will also increase.

On 22/12/2016, the Prime Minister issued a decision approving the orientation for development of urban water supply and industrial parks in Vietnam by 2025 with a vision to 2050. Accordingly, the targets and specific targets to 2020 are as follows:

- The rate of coverage of clean water supply services from urban water supply systems in urban centers of grade IV or higher shall be 95% and 80% for grade-V urban centers with a water supply norm of 120 liters / person / day and night. , water quality meets technical standards as prescribed; Industrial parks are adequately supplied with water according to pressure and flow requirements.
- The rate of urban water supply and drainage systems is 45%; The rate of loss of clean water collection is less than 18% for urban centers of grade IV or higher, less than 25% for grade-V urban centers; Water supply service is continuous, enough 24 hours a day for urban centers of grade IV or higher and water supply to suit the actual demand and conditions for urban centers of type V.

Target and specific targets to 2025:

- The coverage of clean water supply services from urban water supply systems shall reach 100%, with an average water supply norm of 120 liters / person / day and water quality up to the prescribed standards. Industrial parks are adequately supplied with water according to pressure and flow requirements.
 - The rate of urban water supply systems shall be 75% for the establishment and

implementation of safe water supply plans; The rate of loss of clean water collection in urban areas is less than 15%; Continuous water supply service, 24 hours full pressure on the day.

Vision to 2050:

Meet all needs and ensure safe water supply for daily life and production of urban, residential and industrial areas.

With the increasing demand of clean water in the province, the company has many opportunities to expand production, increase sales. In addition, with the orientation to focus on developing the traditional sector and having the strength of clean water business and constructing and designing water supply and drainage works ..., creating opportunities and potential for development. company in the future

3. Evaluation of the development orientation of the company with the direction of the industry, the policy of the State

Due to the characteristics of the service business and the current situation of the country and the world are attaching importance to the development and protection of the natural environment, Kon Tum Water Supply Company Limited has been active to seek and exploit new customers in the locality and proceed to invest in the construction of water supply systems for deep-lying and remote areas. In addition, the Company also plans to continue investing in machinery and equipment, build quality management system and improve the level of staff and employees to achieve high efficiency and limited service. maximizing risks, ensuring sustainable development.

The development orientation of the company is built in a way that is appropriate and in line with the view and direction of development of the sector, based on the results of understanding the market needs in the water supply sector as well as the main orientation, books of the State.

X. INVESTMENT PLANS AND DEVELOPMENT STRATEGY OF ENTERPRISES AFTER EQUITIZATION

1. Development orientation of the company after equitization

After completion of equitization, the company determines the maximum resources for its main business is the exploitation, production and supply of clean water, specifically:

- Focusing on investment for source development: Increase the efficiency and capacity of water treatment at the water supply plant to actively meet the demand of water use of existing customers and to supply water to customers in new areas.
- To concentrate investment in developing the water supply network: To invest in extending the coverage of the water supply system under the management of the company (water supply network, transmission, distribution and service network) in accordance with the water supply planning of Kon Tum province: Install more water meters, and lower the cost of installation equipment.
- Reduce loss rate: For enterprises operating in the field of water supply and production, it is extremely important to reduce the rate of loss and loss of water during transmission and supply. Therefore, the company always focuses on inspection, control, upgrading transmission system to reduce the loss rate.

XII. PROPOSED RISKS

1. Economic risk

Joining the World Trade Organization (WTO) since 2007, the Vietnamese economy has experienced positive growth thanks to world economic policies and the expansion of exchanges and cooperation with many countries in the world. However, besides favorable conditions for the signing of trade agreements, competition has been on the rise, with foreign firms entering Vietnam increasingly challenging the domestic ones.

In 2017, Vietnam's macro economy is more stable and regains its high growth momentum. In 2017, gross domestic product (GDP) is estimated to increase by 6.81% compared to 2016; higher than the target of 6.7% and the growth rate is highest in the last 10 years. However, in addition to these positive signals, any economy contains certain

risks. Performance and business prospects posed the need for businesses to adapt in time to the volatility of the elements from the business environment. Economic risk is defined as the type of systemic risk resulting from macro factors, in which the fundamental factors affecting business operations are: i) economic growth and publishing; ii) inflation rate and iii) interest rate. Analyzing the macro environment of the economy in order to prevent the impact of risk factors on the growth strategy and ensure the operation of the business model.

Legal risk

Issuance or change of new policies and regulations related to the operation of the sector affects the Company. Although Viet Nam has tried to build up and formed an open legal environment in recent years, the legal corridor of our country has not been completely and completely stable, thus affecting the most. Determining the business efficiency of the company.

After equitization, the Company's operations have been subject to the Law on Enterprises and the Law on Securities. However, the legal system of Vietnam is not synchronous, is in the process of finishing the new Decree, Circular, guiding documents are not enough, the stock market is a new field. Businesses as well as investors are not really knowledgeable to perform properly. Therefore, if any change will affect the production and business activities and stock trading of the Company.

3. Specific risk

- a) Risks from natural water extraction
- Natural water is the raw material for production of clean water exploited by the company from rivers and tributaries in the area. However, the upstream waters of the river, under the regulation of upstream hydroelectric dams, are unstable. Therefore, Kon Tum Water Supply Joint Stock Company may face risks from the natural condition of the changed water source. Changes in quality and raw water flow greatly affect the processing and production of clean water.
- Rapid industrialization and industrialization also entails the risk of high water pollution. The factories do not have proper wastewater treatment system, agricultural production uses a lot of chemicals such as fertilizer, pesticides, causing the risk of water pollution. In recent years, the weather has changed quite erratically, the dry season lasts, the source of clean water is contaminated by salinity, so it affects the raw water supply.
- In order to prevent such risks, the Company needs to focus more on the development of water treatment operations to ensure the quality of water supplied to customers.
- b) Risk of water loss

- Due to the long pipeline system has been invested long time, at the time of population is sparse. Plumbing has been used for a long time, can carry the risk of failure, break pipes, ... causing water losses. In addition, as the pace of urbanization is rapidly developing, the high population density has made it difficult to manage, renovate and repair old piping systems in some areas. costly.
- Currently, the Company is applying and researching more advanced techniques in the management of water supply system to minimize water loss.
- The company mainly operates in the field of business of clean water serving mainly depends on people's consciousness.

4. Risks of the offer

After more than 25 years of existence and operation, the stock market in Vietnam has achieved certain successes as market size increases over the years. However, besides, there are many shortcomings such as market size is not matching with potential development, product is poor, knowledge of investors on the stock market is limited, the first private action mainly in the crowd, ...

With the current situation, Vietnam stock market is in the correction period due to the negative impact from the general economic decline. On the other hand, the psychology of investors is not really stable, is waiting for the positive action of the Government and positive signs from the economy, leading to the situation of trading of stocks on both The stock market and the OTC market are not very exciting. Therefore, the offering of shares to the public at this time will face some disadvantages and disadvantages. However, the positive response of the economy to recent government regulation policies and beliefs seem to have been somewhat reversed where investors can promise a more lucrative return. of the stock market next time.

The Company's shares have not been put into trading, therefore, liquidity is lower than that of companies operating in the same field with shares listed on the exchange. The stock offering of the Company will depend on the situation of the stock market listed at the time of the auction, the psychology of the investors as well as the attractiveness of the shares of the company.

5. Another risk

In addition to the above mentioned risk factors, there are risk factors due to natural phenomena such as natural disasters (storms, floods, droughts, epidemics and earthquakes). ..), war or fire ... These risks will cause many difficulties and have a great impact on the Company's business
